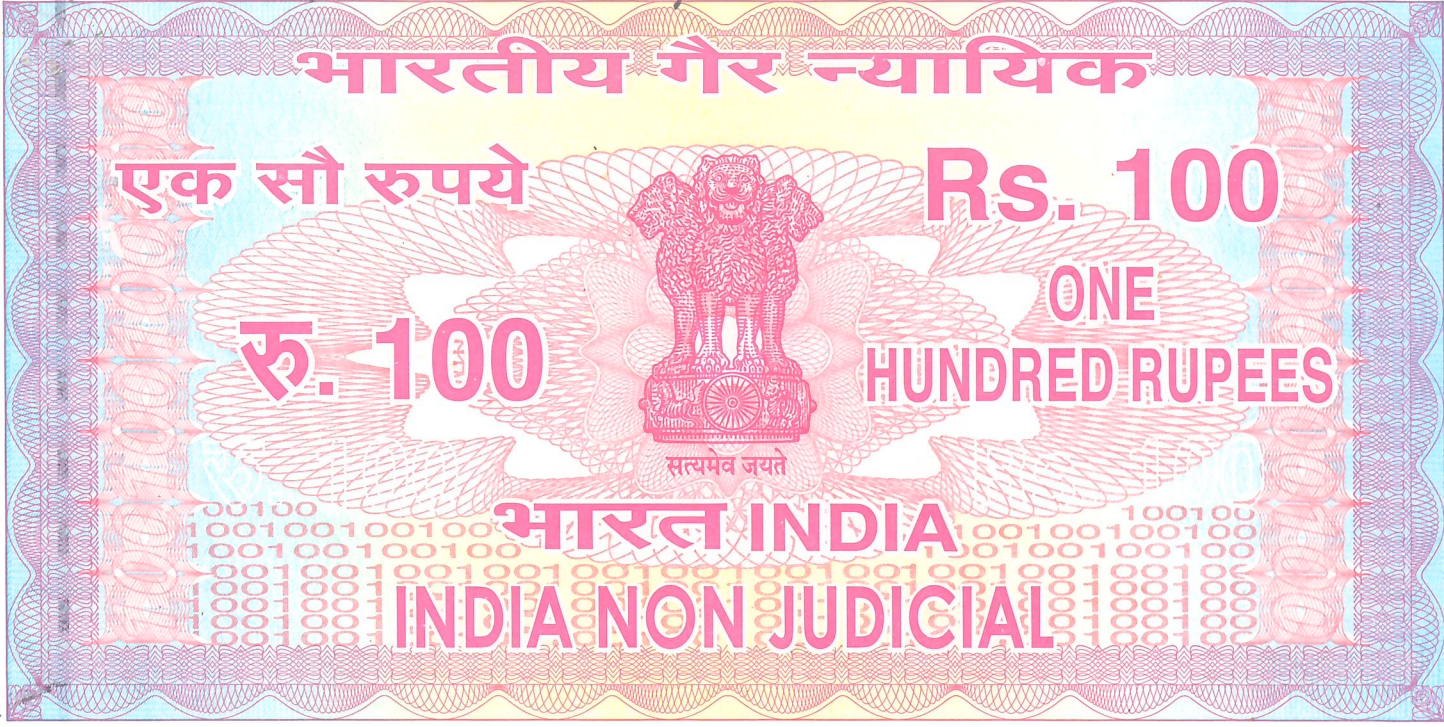

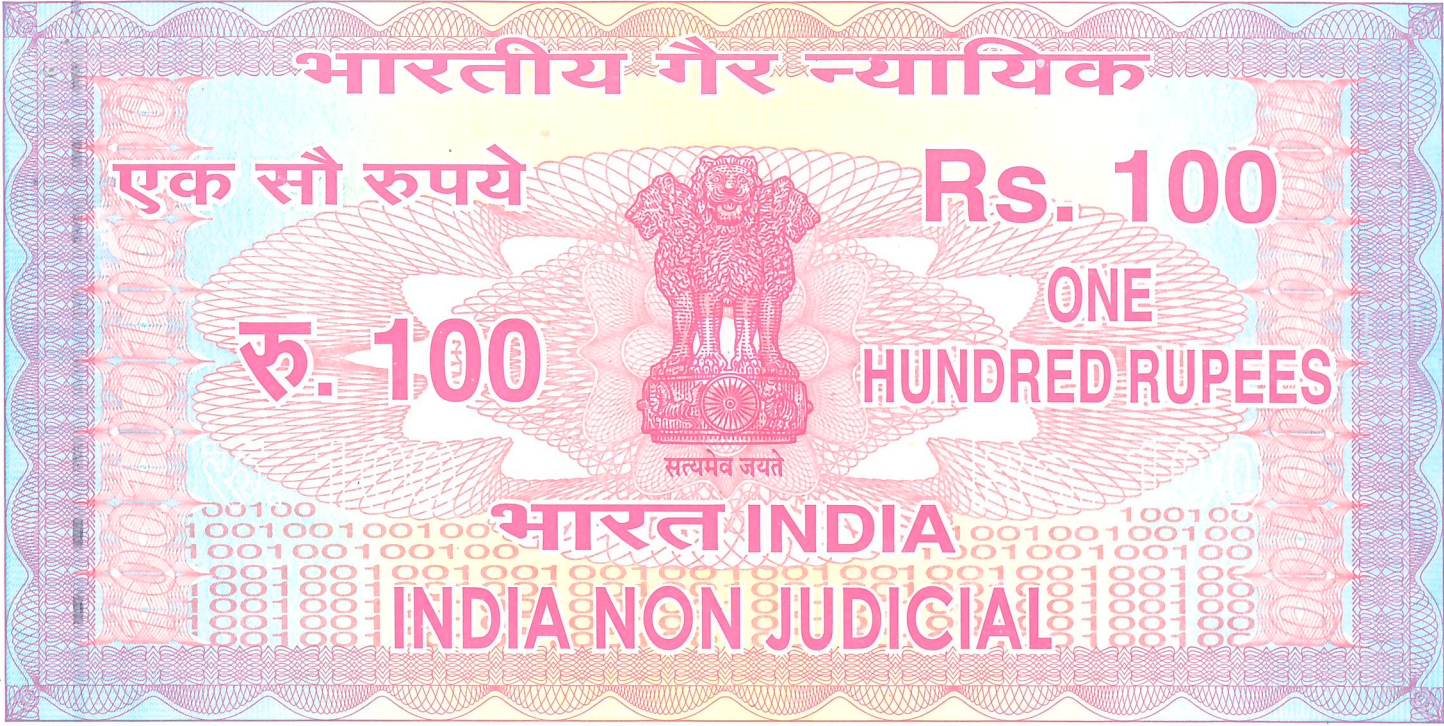

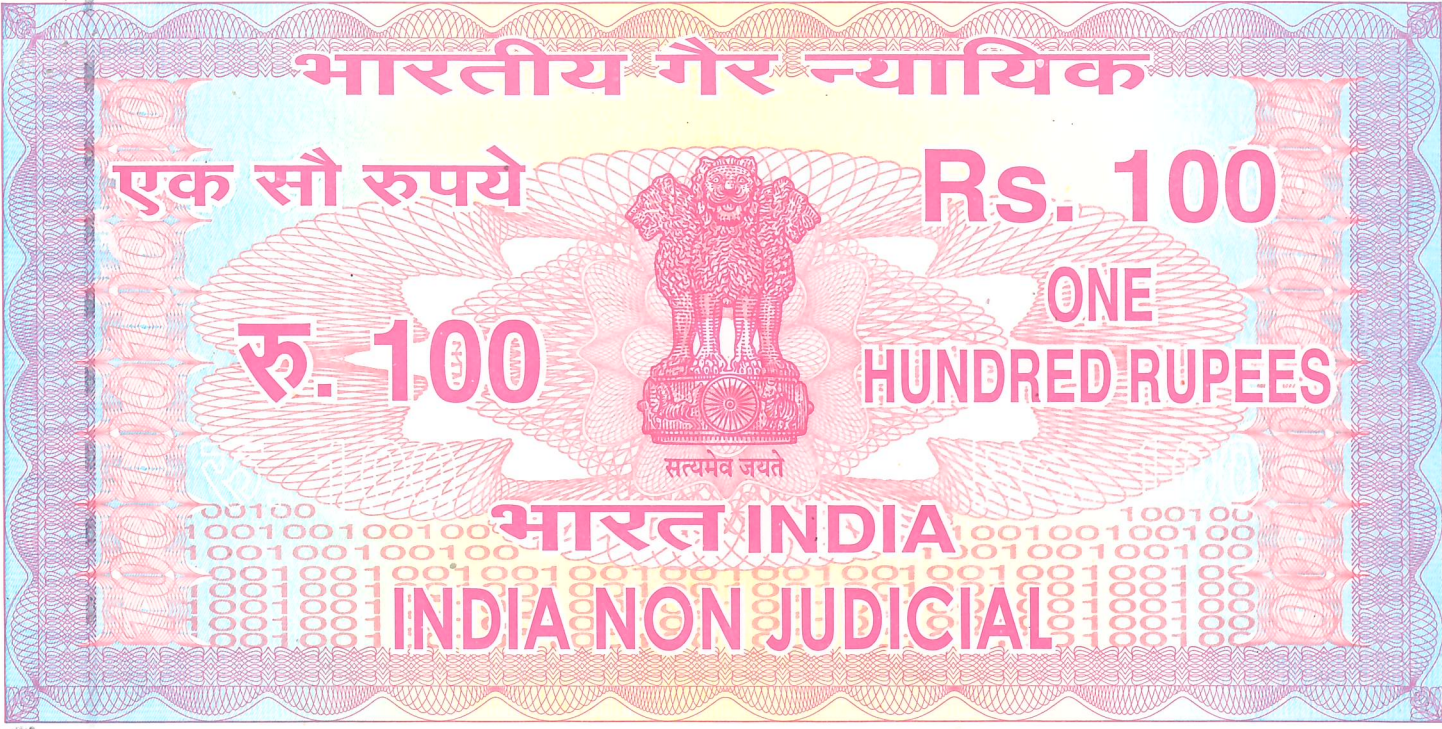

NOW THIS INDENTURE is hereby agreed and declared as follows:-

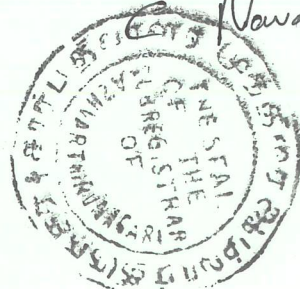
I. That, in order to effectuate his aforesaid desire, the FOUNDER TRUSTEES has set apart a sum of Rs.1,000 (Rupees one thousand only) hereinafter called the 'Trust Fund' which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

II. NAME OF THE TRUST

The Educational and Charitable Trust hereby created shall be known as "**KAMARAJAR EDUCATIONAL TRUST**" or such other name as may be decided by the Board of Trustees from time to time and shall hereinafter be referred to as "TRUST".

III. PLACE OF TRUST

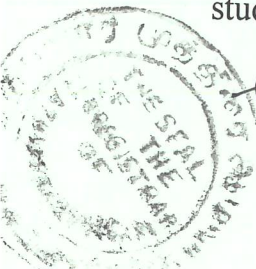
The Trust shall hold its principal and registered office at **No.13/3D, Main Road, Lakshmipuram, Nalumavadi – 628 211, Eral Taluk, Tuticorin Dist .**

The office may be shifted to and/or situated at any other place or places as may be decided upon by the trustees from time to time. The Board of Trustees may decide and have any number of branches within India for achieving the objects of the Trust.

IV. THE OBJECTS OF THE TRUST TO BE PURSUED ARE AS FOLLOWS:

A. MAIN OBJECTS

1. To establish new or take over and administer Government aided and/or unaided Primary Schools, High Schools, Higher Secondary Schools, Matriculation Schools, CBSE Schools, ICSE Schools etc.
2. To establish, run, support, maintain and grant aid or other financial assistance to schools, Arts and Science colleges, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
3. To establish, promote and give scholarships, grants, stipends, loans, prizes, rewards etc., in recognition of merit, talents, brilliance, to conduct talent tests and to provide help to persons seeking to pursue further studies and research in any field in its widest ramification especially all incidental expenses such as travelling, boarding and lodging expenses for students going abroad for higher studies and to give free gifts of books, apparatus, instruments or payment of fees to poor and deserving students.

4. To provide supplementary education for the school going children and help them to improve in their studies.
5. To provide extra-curricular activities i.e. games, quiz programmes, exposure visit, etc. in order to develop their hidden talent.
6. To arrange vocational training for poor girls/students/women/youth with the help of government and other voluntary agencies.
7. To provide hostel facilities especially for poor students so that they can do better in their studies and other activities.
8. 10. To establish, support, maintain, run or grant aid to institutions for the promotion of education in the area of science, literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institutions, in India, having similar objectives for the benefit of the public in general.
11. To establish, maintain or grant aid for the establishment and / or maintenance of parks, gardens, gymnasiums, sports clubs, swimming pool, dharmas and rest houses, for use by public in general at free of cost for the furtherance of the objectives of the trust.
12. To open, establish, take over promote, set-up, run, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running hospitals, charitable dispensaries, maternity homes, adult education centre, leper homes, children homes, child welfare centre, and homes for the blind, the deaf-mutes, the mentally retarded, paraplegics, leprosy home, widow welfare programme, prison children's and physically handicapped person's welfare programme, convalescent homes, sanatoriums, hostels and other similar institutions or centre for rendering or providing medical relief.
13. To grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, Tsunami, fire, pestilence etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.
14. To grant aid or render assistance to other registered public charitable trusts or institutions.
15. To purchase, take lease or hire or otherwise acquire and hold and also to sell, transfer or ease any movable property or any rights or privileges for the furtherance of the objectives of the Trust.

16. To publish and to help in the publication and circulation of books, journals, periodicals, bulletins, lectures and other reading materials, etc. with a view to advance the cause of education and social awareness.
17. The above mentioned objects will be carried out without the intention of making profit and should be incidental to the attainment of the object and the conditions stipulated in sec.11(4) and the provision to sec.80(5) (1) of the I.T. Act, 1961 will be satisfied.

B. OTHER OBJECTS

1. To receive grants and get donations and gifts in cash or kind or property, whether movable or immovable from various Government and public donors for the welfare activities of the society and for the furtherance of the objects of the TRUST.
2. To acquire, manage, sell, transfer, pledge or otherwise dispose off or deal with property of any kind (movable and immovable) which may be at the disposal of the Trust in order to promote its objectives.
3. To enter into contract for and in connection with any of the purposes of the Trust.
4. To appoint, employ, deploy and pay remuneration to officials, staff, workers, agents and consultants for the purpose of managing the office of the TRUST and its projects.
5. To institute, conduct, defend, intervene in or compromise legal proceedings by and against the Trust.
6. To provide all the welfare benefits viz., EPF, ESI, retirement benefit scheme etc. to persons employed and the immediate dependants of such persons (not for trustees/office bearers of the trust).

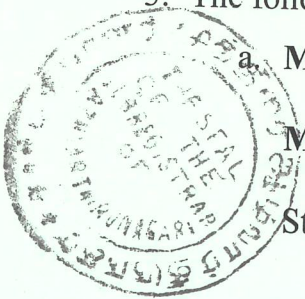

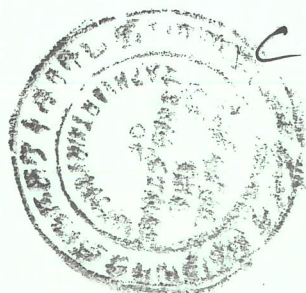

9. (1) The board of trustees, may nominate one of the trustees as Correspondent for the proposed schools to be established. Now the board has decided to establish a Matriculation School under the name and style of “ **KAMARAJAR NURSERY & PRIMARY SCHOOL**”.

(2) The board of trustees nominated Mr.C.Navaneedhan as Correspondent of the school - **KAMARAJAR NURSERY & PRIMARY SCHOOL**. The term of correspondent will be determined in the duly convened meeting of the board of trustees. However the term should not exceed 3 years.

7. The trustees may from time to time frame rules for the conduct and regulations of the trust, schools, Institutions etc.....

VII. ANNUAL GENERAL BODY MEETING (AGM)

1. The Annual General Body Meeting (AGM) of the Trust shall be held once in a year within 6 months from the end of the financial year, duly giving a notice of 21 days.
2. The following business will be transacted in the AGM.
 - a) Approval of accounts and budget.
 - b) Selection of the trustees / office-bearers.
 - c) Appointment of Auditor.
3. The simple majority of the members of the Trust shall be the quorum for the AGM.
10. In addition to the annual general body meeting, if necessary extraordinary general body meeting may be convened by duly giving notice of 21 days.

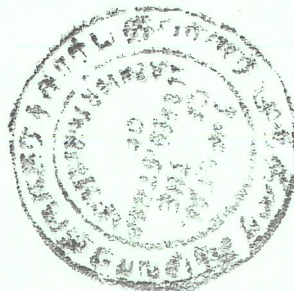

8. To open account in the name of the Trust, Trustees and/or Institutions run/ conducted by the Trust with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
9. To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.
10. To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.
11. To appoint or make provision for the appointment of any person (including all or any of the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.
12. To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
13. To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.

14. To set apart and/or allocate the whole or a part of the income or the corpus of the trust Fund or part thereof for any of the objects of the Trust.
15. To join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.
16. To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organisations or Trusts in India which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, Organisation or Trustees to start maintain, or carry out such charitable objects.

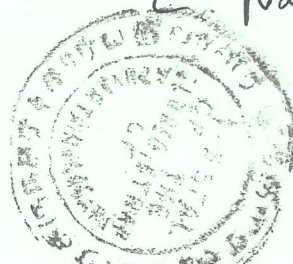


19. To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.
20. To take over or amalgamate with any other charitable trust, society, association, or institution with similar objects.
21. To establish, promote, manage, organise or maintain or to assist in establishing, promoting, managing, organising, or maintaining any branch of the Trust or any other Trust or its branch with objects similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.
22. To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
23. To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
24. To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or more of the trust, societies, institutions or associations with which this Trust is authorised to amalgamate.

25. To transfer and hand over the Trust to any other Society, Corporation, Institution, Trust or Organisation on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the Society, Corporation, Institution, Trust or Organisation with the powers, provisions, agreements and declarations, appearing and contained in these presents subject to such modifications as may be necessary and consequent to such transfer of the Trust fund. The Trustees for the time being of these presents shall become discharged from the Trust thereof relating to Trust Funds so transferred.
27. In execution of the powers of the trustees, it should have been duly approved by majority of the trustees by making a resolution in a duly convened board meeting. In the case of equality of votes on any decision, the Managing Trustee has an additional casting vote in favour or unfavour of the decision and he has the final authority on any decision.
28. The income and funds of the Trust will solely be utilized for the objects mentioned in Clause IV and no portion of it will be utilized for payment of the Trustees by way of profit / dividend / interest etc.

IX. BANK ACCOUNT

The Trust shall maintain bank accounts with any bank in the name of the Trust and the bank account of the Trust shall be operated jointly by the Managing Trustee along with any one of the trustees duly authorized by the Board of Trustees.

Additional bank accounts may be opened in the name of the trust and be operated by any persons duly authorized by the Board of Trustees.

The account in the name of the school may jointly be operated by the Correspondent of the school and Principal / Head Master / Head Mistress of the school.

X. INVESTMENTS

All money that shall not immediately be required for current expenses shall be invested by the trustees in investments and securities authorised by section 11 (5) read with section 13 (1) (d) of the Income Tax Act, 1961 and the investments shall not deviate from the provision of any clauses pertaining to public charitable trust under Income Tax Act, 1961 for the time being in force.

XI. TRUST PROPERTY

All properties and investments belonging to the Trust shall be vested in the trustees for the time being. On any trustee ceasing to be a trustee, the Trust properties and investments shall cease to vest in him and on the coming of any new trustee, the Trust properties and investments shall vest in him also along with the other continuing Trustees.

Upon every appointment of trustees and upon every retirement of the trustees, such deeds and other acts as the trustees may prescribe for the purpose of vesting all properties of the Trust then vested in any surviving or continuing or retiring trustee or trustees or any personal representative of any last surviving trustees in the Trust for the time being jointly shall be executed and done.

XII. CUSTODY OF DOCUMENTS

The MANAGING TRUSTEE or any other person duly authorized by the Board shall have custody of all the deeds and documents of title relating to the Trust properties and investments and the books of accounts and other records relating to the Trust and shall be responsible for the same.

XIII. ACCOUNTS AND AUDIT

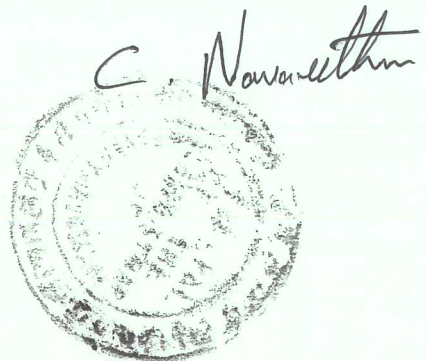
1. The MANAGING TRUSTEE or any other person duly authorized by the Board shall keep proper accounts of the income and expenditure of the Trust and shall prepare the financial statement and balance sheet for every year as on 31st March and the accounting year of the Trust is the financial year.
2. The accounts of the Trust shall be audited by a Chartered Accountant duly appointed by the Board of Trustees and the audited statement of account shall be placed before the Board for its approval within six months from the close of the accounting year.

XIV. AMENDMENTS

While this Trust shall be irrevocable, the Board may amend the clauses at a duly convened meeting of the Board by a resolution passed by a three fourth majority of which resolution at least 21 days notice has been given and amendments should be carried out only with previous approval of the Commissioner of Exemptions, Chennai. It would not extend to altering the basic character of the Trust and further no such amendments which may prove to be repugnant to the provisions of sections 2(15), 11, 12 & 13 and 80 G of the I.T. Act, 1961 shall be made.

XV. DISSOLUTION OF THE TRUST

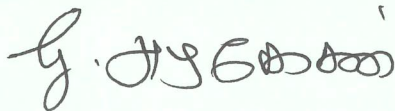
